Uneven Ground Slips/trips/falls	Participants, stewards, volunteers, contractors	HIGH	<ol> <li>Appropriate footwear to be worn.</li> <li>Organisers to brief all involved in event on potential on-site / en-route hazards.</li> <li>Remind participants to run carefully and responsibly, keeping a sensible distance between themselves and others.</li> <li>All participants to carry emergency contact number in case of incident.</li> <li>Emergency access points to be identified in case of incident.</li> <li>Walk at a comfortable place.</li> <li>Anglers are recommended to carry their own First Aid kit.</li> </ol>	MODERATE	05/02/2022



Drownings Lifejackets	Participants, stewards, volunteers, contractors	HIGH	<ol> <li>All anglers must wear a lifejacket that has been adjusted to their body size or the fishing permit for the boat will be withdrawn.</li> <li>Ask for assistance in putting on lifejacket if unsure. Any life jacket that has been set off must be handed back to staff. There is no penalty for accidental triggering.</li> <li>Any person seen by anglers not to be wearing a lifejacket should be reported by anglers to organisers or bailiff's.</li> </ol>
Boats Getting on, off & moving around on boats	Participants, stewards, volunteers, contractors	HIGH	<ol> <li>Boats constantly move and are unstable when their balance is disturbed. The motion of the boat and getting on, off and moving around on boats disturbs the balance, hence maximum caution is needed when getting on, off and moving around on boats.</li> <li>All boats scrutineered prior to fishing to ensure all steering equipment in good working order. Competitors led on "sighting lap" prior to fishing start to ensure competitors</li> </ol>

Boats Other Boats	Participants, stewards, volunteers, contractors	HIGH	1. Beware other boats can approach you from all angles and may be unpredictable in their direction, when "on the motor" you should always give way to those drifting or under sail.
Boats Boat engines	Participants, stewards, volunteers, contractors	MODERATE	1. Breakdowns can occur. Never lean over the side to fix an engine. Call for help to a ranger.
Boats Drogues	Participants, stewards, volunteers, contractors	MODERATE	1. Take extra care when pulling in or setting a drogue. Make sure you are seated and have a firm foothold. Drogues can become tangled around propellers – take the boat to the shore or call a ranger to untangle the rope.
Boats Under 16	Participants, stewards, volunteers, contractors	MODERATE	1. No under sixteen may drive at any time under any circumstances.
Water Falling in lake	Participants, stewards, volunteers, contractors	HIGH	1. Event to be stewarded. 2. Be advised to stay away from the edge of any platforms. 3. Wear suitable footwear to reduce the risk of slipping.  MODERATE  05/02/2022

Water Weil's disease	Participants, stewards, volunteers, contractors	HIGH	1. Weil's disease is transmitted in rat urine. Anglers are reminded to not put wet line or equipment in mouth. Wash hands before eating or smoking. Undesirable bacteria may also be present in animal droppings and lake water. Take suitable precautions.  2. Anglers are recommended to carry their own First Aid kit.
<b>Water</b> Wading	Participants, stewards, volunteers, contractors	HIGH	1. All involved to be reminded that wading at the lake is strictly prohibited.  MODERATE  05/02/2022
Weather Dehydration	Participants, stewards, volunteers, contractors	MODERATE	1. Participants are made aware of any extreme weather conditions and advised to keep hydrated.  2. Do not drink alcohol.
Weather Hypothermia	Participants, stewards, volunteers, contractors	MODERATE	1. Advice participants to wear appropriate clothing.  2. Warm drinks to be available.

Weather Strong wind, thunderstorms, lighting	Participants, stewards, volunteers, contractors	MODERATE	<ol> <li>Assess weather conditions before and during event.</li> <li>When boat fishing, the weather may change suddenly and cause unforeseen dangerous water conditions. Be constantly aware of changing weather and its consequences.</li> <li>Fishing under trees can be unsafe on windy conditions. Beware of falling trees or branches.</li> <li>Rods are good lightening conductors, please do not fish in these conditions, and seek refuge well away from trees. A good refuge is a car.</li> <li>If conditions are extreme, session is to be postponed.</li> </ol>	05/02/2022
Injury From hooks / rod / weights / lines / needles	Participants, stewards, volunteers, contractors	MODERATE	<ol> <li>Participants to be instructed on safe handling of rods. Rod tips should remain up and a distance between participants when walking or standing in a group adhered to.</li> <li>Hooks are to be connected to</li> </ol>	05/02/2022



			eyelet of rod when in transportation and or walking.  3. Anglers are advised to take care if their tackle (hooks, weights) are stuck in trees undergrowth or branches. A release of tackle or a part of the tree may cause injury.  4. Beware fishing hooks are sharp and lines, wire traces can cut deep.  5. Weights and tackle can cause injury to others.  6. Beware sharp tools such as forceps, wire cutters etc. can cause an injury to anglers and others.  7. Emergency access points to be identified in case of incident.  8. Anglers are recommended to carry their own First Aid kit.
Injury From casting	Participants, stewards, volunteers, contractors	HIGH	<ol> <li>There is to be a 2 metre space between any participant or other person in the boat where the activity is conducted.</li> <li>Weights and tackle can cause injury to others.</li> <li>Anglers are advised to wear glasses to protect their eyes.</li> <li>Anglers are recommended to carry their own First Aid kit.</li> </ol>



<b>Injury</b> From machinery	Participants, stewards, volunteers, contractors, general public	HIGH	Do not touch any machinery which is owned by the fishery.	MODERATE	05/02/2022
Medical conditions Asthma and other medical conditions.	Participants, stewards, volunteers, contractors	HIGH	<ol> <li>Participants are advised to let instructor know if they suffer from asthma. An inhaler is to be carried by affected participants.</li> <li>Any appropriate medication is to be carried during session.</li> <li>The individual participates at their own risk.</li> </ol>	MODERATE	05/02/2022
Barbeque Fire, burns	Participants, stewards, volunteers, contractors, general public	HIGH	<ol> <li>Be aware of the fire and burns risks whilst working with associated equipment.</li> <li>Emergency fire blankets will be available.</li> <li>BBQ is sited in an area free of vehicle and pedestrian traffic.</li> <li>Manufacturer's instructions should be followed at all times when doing BBQ.</li> <li>A fire extinguisher (water) is available, sited near BBQ (if charcoal is used). A Dry Powder is needed if the fuel used is Gas.</li> <li>Long hair and long sleeves are to be tied back.</li> <li>A charged mobile telephone is</li> </ol>	MODERATE	05/02/2022

Barbeque Food poisoning	Participants, stewards, volunteers, contractors	HIGH	<ol> <li>BBQ will be maintained by qualified chef.</li> <li>Chef to follow manufacturer's instructions at all times when cooking.</li> <li>Food to be thoroughly cooked before being served.</li> <li>If available a refrigerator to be used to store uncooked food. If not then a cool bag/box with ice to be used to keep uncooked food chilled.</li> <li>Burgers, sausages and chicken must not be reheated.</li> <li>Personal hygiene rules are</li> </ol>



			followed at all times (after using the toilet, eating, and handling food products) to ensure that the risk of the BBQ bug (Campylobacter) is greatly reduced.		
Welfare facilities Toilets, showers, hot water	Participants, stewards, volunteers, contractors	HIGH	1. Toilet and showers have been provided by the management of the fishery complex. Please be aware that the floor can be wet and slippery. Be aware that there is also hot water that could scold if not used correctly.	MODERATE	05/02/2022
Vehicle Carp park, driving on the complex	Participants, stewards, volunteers, contractors	HIGH	1. All persons must keep to (5 mph) speed limit whilst driving on the complex. Only use the car parks and parking areas provided. Always be aware of the people, dogs, wildlife or machinery whilst driving on the complex.	MODERATE	05/02/2022
